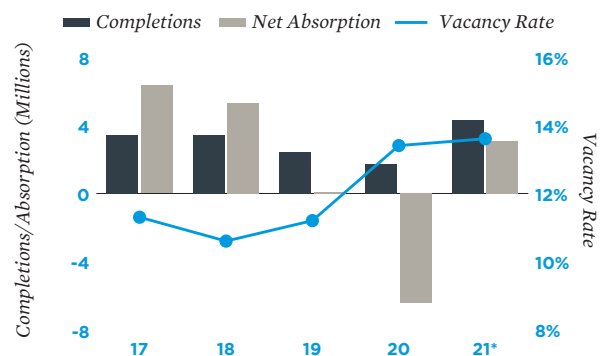

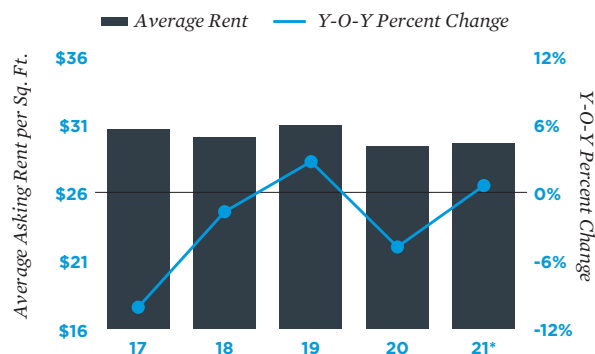

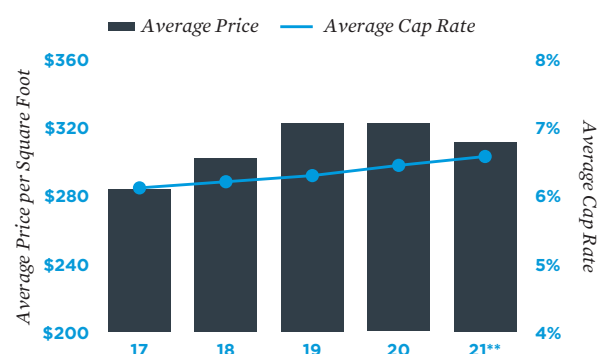
Supply and Demand
