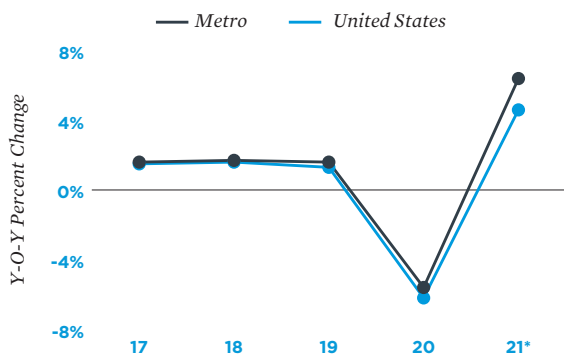

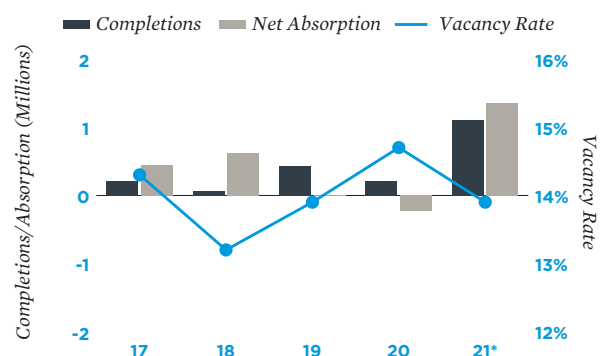

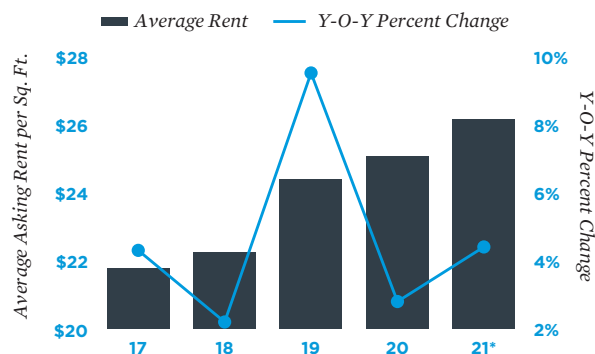
Employment Trends



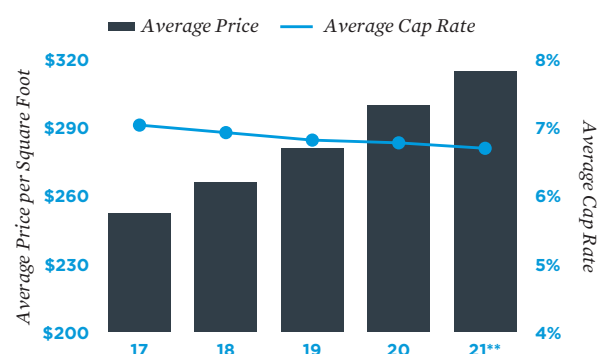
Supply and Demand
