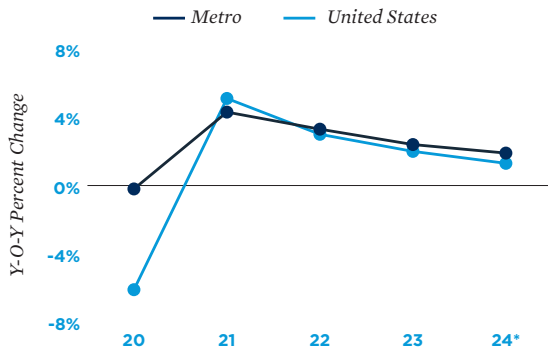

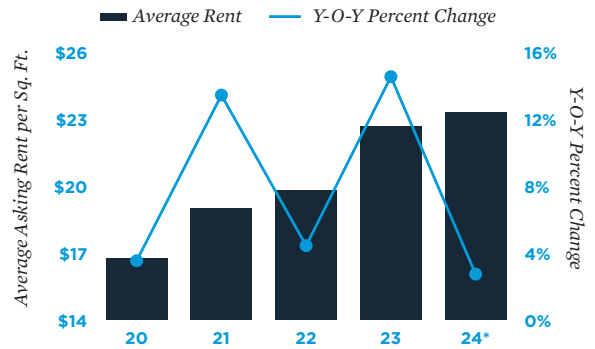

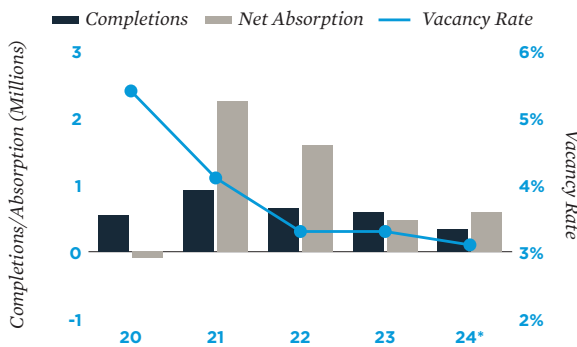

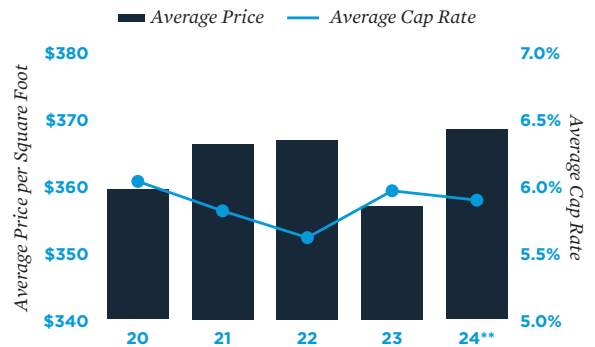
Rent Trends
