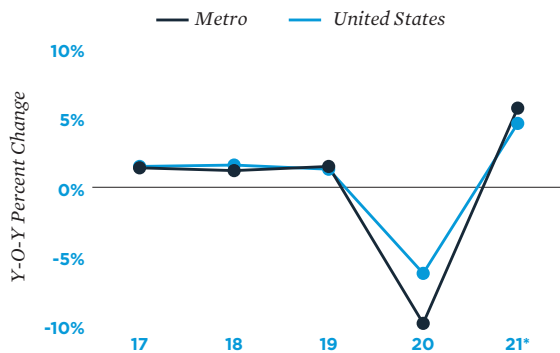

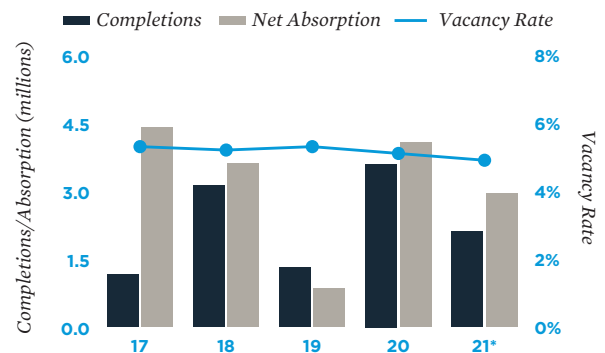

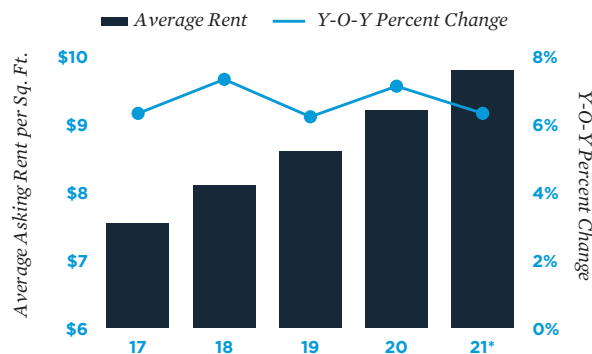

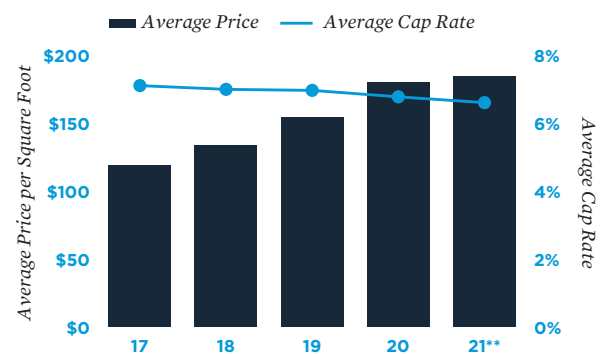
Supply and Demand
